Participants will also learn the components and structure of Teaching Strategies GOLD. Through video clips and large group discussions, participants will explore the progressions of development and learning for children birth through kindergarten.

Additionally, participants will have the opportunity to explore and practice using the technology side of Teaching Strategies GOLD. By the end of this session, participants will have an understanding of how to implement the online version of Teaching Strategies GOLD.
