WE DO NOT DISCRIMINATE

Under Titles VI and VII of the Civil Rights Act of 1964 (Title VI and VII) and the Americans with Disabilities Act of 1990 (ADA) Section 504 of the Rehabilitation Act of 1973 and the Age of Discrimination Act of 1975, Victim Witness Services (VWS) prohibits discrimination in admissions, programs, services, activities or employment based on race, color, religion, sex, national origin, age, and disability. VWS must make a reasonable accommodation to allow a person with a disability to take part in a program, service or activity. Auxiliary aids and services are available upon request to individuals with disabilities. For example, this means if necessary, VWS must provide sign language interpreters for people who are deaf, a wheelchair accessible location, or enlarged print materials. It also means VWS will take any other reasonable action that allows you to take part in and understand a program or activity, including making reasonable changes to an activity. If you believe that you will not be able to understand or take part in a program or activity because of your disability, please let us know of your disability needs in advance if at all possible. Our advocates provide a multitude of services to help victims, witnesses and survivors of crime and crisis.

Services Available:

- Court escort for victims & family members
- Orders of Protection & Injunctions Against Harassment
- Case Management
- Referrals for emergency shelter
- Referrals for community resources
- Application assistance for Victim Compensation
- Employer and school mediation
- Transport to and from court or shelter
- Support for survivors of deceased loved ones

24/7 CRISIS RESPONSE

Crisis Response Advocates are available 24/7 to respond on scene and provide advocacy to clients and victims of crime and crisis.

Pet's Too!

A unique program that allows individuals who are fleeing domestic violence or who are emergency relocating to temporarily place their pet in a local safe haven.

Trauma Sensitive Yoga

Professionally facilitated yoga for all. Call for details.

Sexual Assault Peer Support Group

A support group for those who are providing support and care for victims and survivors of sexual assault

Domestic Violence Support Group

A weekly professionally facilitated group. Children's Support Group occurs at the same time in a safe, confidential, nurturing environment.

Victim Compensation Program

Coconino County's Victim Compensation Program assists victims of crime with out of pocket expenses that are the direct result of a crime. The Victim Compensation Program **may** cover medical costs, counseling, funeral expenses, lost wages, and other approved expenses. The Compensation Program is a payer of last resort.
